MINUTES

1. Opening & Consider Agenda (10 min.)

A motion was made by Ed and a second from Ken to approve the agenda. All were in favor; agenda approved.

- Approve [12/9/20 Meeting Minutes](#)

A motion was made by Chris and second from Ken to approve the 12/9/20 meeting minutes. All were in favor; minutes approved.

- Treasurer's Report [Monthly Financial Report](#) and [Bank Statements](#)

Chris shared an update on the membership dues and profit/loss for the financial year. We have not hit budget goals yet however Chris noted that we are just beginning the business sponsorship campaign so we anticipate funds coming our way from that source. All but one lake association memberships have been renewed and it is anticipated the remaining one will be received soon.

A motion was made by Ed and a second from Scott to approve the Treasurer's Report. All were in favor; minutes approved.

2. Updates (25 min.)

- [SWCD Cost Share Program](#)

Dan shared an overview of the cost share program for 2021. The program offers a higher cap this year compared to years past. A Cost Share flyer is available that explains the funding specifics and the process to get a project installed on your property. The SWCD will have a webinar series in March that people can attend which will inform them about practices including stormwater pollution practices, forestry, pollinators, shoreline restorations, etc.

Patrick and Sanford also shared information about different webinar programs that are occurring this year. Patrick will send an email out with this information.

- 2020 WaterGuards Inspection Report

Dan shared slides from a fall AIS Task Force meeting about inspection data from the 2020 program. The PowerPoint will be posted to the SWCD website soon for viewing.

Scot shared that he had spoken with DNR staff about the AIS volunteer program and that there is a possibility of this program moving forward in 2021, but they are waiting for approval from senior staff and COVID-19 safety protocols.

- Golden Clam Education Field Day

Dan discussed the Golden Clam monitoring program and shared that the selected dates, Feb 12 and 16, look to be too cold to host an outing. Dan will look at the month of March to hold an outdoor education event on the Golden Clam. COVID-19 safety protocols will be followed and attendance will be limited. Scot and Sanford have indicated interest in attending this event.

- MN COLA

MN COLA will meet next week and are planning interviews with lake groups on their projects this summer. They are keeping up with legislative issues as well and watching discussion on this closely. An emerald ash borer bill is currently circulating which would provide funding for

treatment and selective removal of ash trees. Sanford will provide notes about the legislative issues being discussed at MN COLA to share with the group.

Sherburne SWCD staff are continuing to identify new projects for this year and which would get a good fit as a partnership with SC COLA.
