1. Opening & Consider Agenda (20 min.)

Chris moved to approve agenda, Scot seconded, motion passed.

Treasurer's Report Monthly Financial Report and Bank Statements

Chris shared the statement of financial position for the COLA, current memberships and business sponsors. Revenues and expenditures are largely on track as anticipated.

Business Sponsorship / Membership Renewal Status and Follow up

The Executive Committee discussed the sponsorship outreach that has been done and what conversations are being held with other businesses. We are likely looking at approx. \$1,000 in sponsorships this year, which the committee felt was good given the complications some businesses have had with COVID-19 and in board members interactions with them. It was discussed that another "push" for sponsorships was not appropriate given previous efforts and complications with COVID.

2021 – 2022 SC COLA Calendar Development

Discussion occurred regarding meeting dates, annual event, annual meeting, and special activities for the summer. COVID-19 will likely continue to impact gatherings into the summer. Discussion was had regarding the desire to hold in-person gatherings versus the need to respect health guidelines and individual's choices regarding their safety. Moving forward, a hybrid model of allowing in-person meetings with optional video connections might be a good approach. This would allow for participation with juggling work schedules, bad weather, etc. All agreed the situation and guidance with COVID can change quickly so we should be ready to adapt. Patrick will put calendars together for the SC COLA Board and Executive Committee with proposed dates that mimic our 2020-2021 schedule.

 - Dan shared that the County Public Works Department and County Attorney's Office are working on a legal agreement for the participants. No word on SC COLA incentive applicability for the project. Dan anticipates having additional information by the next board meeting.

 - Dan mentioned that the Big Lake rain garden project might not be a good one for the SC COLA to sponsor. 5-6 rain gardens are going in, but there is already great cost savings to the landowners due to the city street construction. <u>Discussions are still taking place regarding a stream bank stabilization on the Mississippi River Dan will share more about this as the project is finalized</u>. A grant would be pursued in this late summer which would provide funding in 2022 for the project.
