#### 1. Opening & Consider Agenda (15 min.)

Scot moved to approve agenda, Chris seconded, motion passed.

- Agenda Addition MN Legislature environmental funding

A recent Star Tribune article discusses a debate in the state legislature regarding a proposed clean car ruling and budgets for state environmental agencies, state parks, the MN Zoo, etc. Patrick discussed the potential ramifications, Dan discussed what the funding for several state agencies goes towards. The Executive Committee will keep an eye on the discussions and how it may impact environmental funding.

County-wide Zebra Mussel Expanded Monitoring Plan

Dan shared an update on ZM monitoring for the 2021 season. The approach will be customized based upon two new ZM infestations (Lake Orono and Big/Mitchell Lakes) along with a different approach for lakes not believed to hold ZM. A combination of eDNA pilot project testing, veliger tows, DNR transect snorkel/SCUBA surveys, additional settling plates, and education/outreach for a dock inspection program will be used.

Golden Clam Monitoring update

Dan shared an update on this project and discussed what could be shared at the upcoming Board meeting.

Watershed Monitoring Outcomes

<u>Dan held a Water Plan Advisory Committee Meeting recently where 2019-2020 monitoring outcomes were discussed. This is a lengthy topic. Patrick recommended sharing this information at the upcoming Annual Meeting in August.</u>

Starry Trek 2021 (tentative date Saturday, August 21<sup>st</sup>)

Dan and Patrick were unable to find the date confirmed on the UofM website, but it is assumed that Starry Trek will be the third weekend of August as it has in the past.

AIS Volunteer Inspector Training

The program is operational for this year. Training will occur via an online platform and background checks are a DNR requirement again. Dan has been in contact with groups who were interested in participating in 2020 and discussed 2021 activity in this program.
