1. Opening & Consider Agenda (10 min.)

- A motion was made by <u>Scott R.</u> and a second from <u>Leslie W.</u> to approve the agenda. All were in favor; agenda approved.
- Approve <u>12/14/22 Meeting Minutes</u>
 - A motion was made by <u>Scott R.</u> and second from <u>Mike D.</u> to approve the 12/14/22 board meeting minutes. All were in favor; minutes approved.
- Treasurer's Report Monthly Financial Report and Bank Statements
 - Reimbursement for SWCD for their half of magnet costs received.
 - 7 of 9 memberships fees received. <u>Scot will check on Big Lake/Mitchell Lake on payment</u> status. Karl Krueger from Thompson Lake has indicated that he is checking on theirs.
 - A motion was made by <u>Leslie W.</u> and second from <u>Scot C.</u> to approve the Treasurer's Report as presented by Chris Weber. All were in favor; report approved.

- Mississippi Watershed Comprehensive Plan (1W1P)
 - Outcomes from Open House on January 31.
 - 70 attendee's includes staff.
 - Different stations were available for attendees to see the proposed plans and complete survey responses stating their priorities.

 Dan C. answer cancelled from 2022 due to unpredictable flow conditions, Dan C. will look into if rescheduling is a possibility.
- 2023 Sherburne SWCD Grant Applications
 - Grants are due 2/18/23 and a few have been submitted already.
- Level 1 AIS Inspections Additional Hours Opportunity
 - SWCD contracts with Water guards LLC to get inspectors through the DNR to do level 1 inspections (level 1 speaks to people at boat launches) at boat launches.
 - Contact Dan C. if your association wants to get additional hours at their boat landings, inspectors charges are \$25.60 per hr.
 - Association members can sign-up to complete a DNR volunteer inspectors program and complete 50-100hrs of training individually or as a group, at their boat launches, to get certified and get funding for the hours reimbursed to their association.

 - Patrick emailing out sample request letter to send out to businesses.

- "We Are Water MN" Exhibit and Events (March 2 April 24) during normal business hours
 - 2023 Special Event Planning Sub-committee:
 - Replacing April 5, 2023 meeting to coincide with the We are Waters MN event
 - Have COLA board members sponsor an event to draw in attendee's
 - speaker on blue green algae, which is a topic many people ask about, with an activity and/or exhibit
 - a person (Steve McComas) called "The Lake Detective" to lead or speak at the event
 - Suggested a minimal budget (not to exceed \$500) for a guest speaker (includes time, travel expenses, food, etc.), COLA board has previously had Mike O'Connell from LMI
 - Scott R. suggested James Johnson a speaker from "Fresh Water Scientific"
 - A motion was made by <u>Sharon F.</u> and a second from <u>Scot C.</u> to allow smaller group/committee to discuss event details, speakers and costs not to exceed \$500. All were in favor; motion approved.

- Scott R. and Scot C. volunteered to help with event planning committee
- 2023 Legislative Session Monitoring and Advocacy
 - DNR may possibly get funds for various projects, of \$287.4 million per One MN Budget and Governor Walz.
 - If bills weren't passed in 2022 they will need to be resubmitted for 2023, one is permanent funding for SWCD's.
 - SWCD funding is up for legislative discuss every 2 years, this bill (HF 735) will make the funding permanent.
